## Annual Report - 2019-2020

2020 is a year that the world is going to remember for a long, long time. It has brought an unprecedented medical crisis into the world with the spread of the Corona Virus. The effect of it started from January of 2020 and it spread like a pandemic all over the world. This is the time when doctors, health workers and NGOs are working overtime to help those who need their expertise, treatments and monetary help. At Hari Om Seva trust where all are senior citizens, it has become a challenge to keep the work going at the same time protecting their own wellbeing. Needy patients along with their doctor, in all protective gears, visit the trustee at his home and after ascertaining the genuineness of the requirements, monetary help is sanctioned. Expensive treatments are also sanctioned on phone so that the patient in need is helped. Such is the zeal of continuing the work!

Hari Om Seva trust has kept its promise of serving needy, sick and underprivileged people of the society through its dedicated services. The current fiscal year of 2019-20 brought about a total of 33,954 patients that availed of our services at both Gotri and SSG Hospital in Vadodara. With the Govt. adding extended services to the poor, Hari Om Seva has been able to help those who did not get those facilities and provided for their expenses. The need for medical help is growing as drugs, equipment, diagnostic tests and operations are getting costlier while sickness, poverty and lack of familial help is multiplying. It is the role of Hari Om Trust to act as an intermediary to solve the issues faced by the poor, sick and helpless patient who are coming to the Govt. hospitals. It is the constant enthusiasm of our trustees, dedicated volunteers and benevolent donors that is making this 'God's work' happen giving immense satisfaction to all that are part of the happening.

Our trustees are ever ready for helping those who are coming from far of states like Rajasthan, Madhyapradesh, Uttar Pradesh, etc as well as homeplace Gujarat as the word is spreading about our work.

### **AT SSG**

The trust operates from its designated office opposite ward no 21 from 10.30-12.30, Monday to Saturday. However due to the heavy rush of needy patients around, our trustees are serving overtime many time till 1-1.30pm too During this time, patients who are directed by the doctor come for their various medical needs such as medicines, laboratory tests, MRI, CT Scans, implants and costly operative needs. After ascertaining their financial capabilities, funds are sanctioned towards their needs.

Another group of volunteers work from the junction of all OPDs, helping the patients towards their numerous queries of location and other needs like procuring a stretcher or wheelchair, etc.

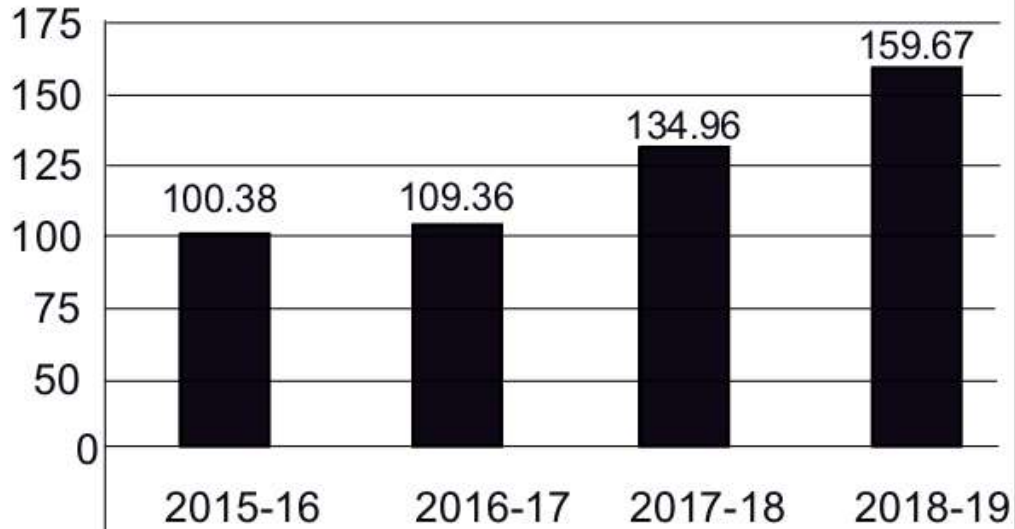
### **AT GOTRI**

Similar office space has been allotted at the Gotri Hospital in the Main Building, First floor near the Paediatric OPD. Dedicated volunteers here help the patients by sanctioning their medical needs and answering their queries regarding locations in the hospital

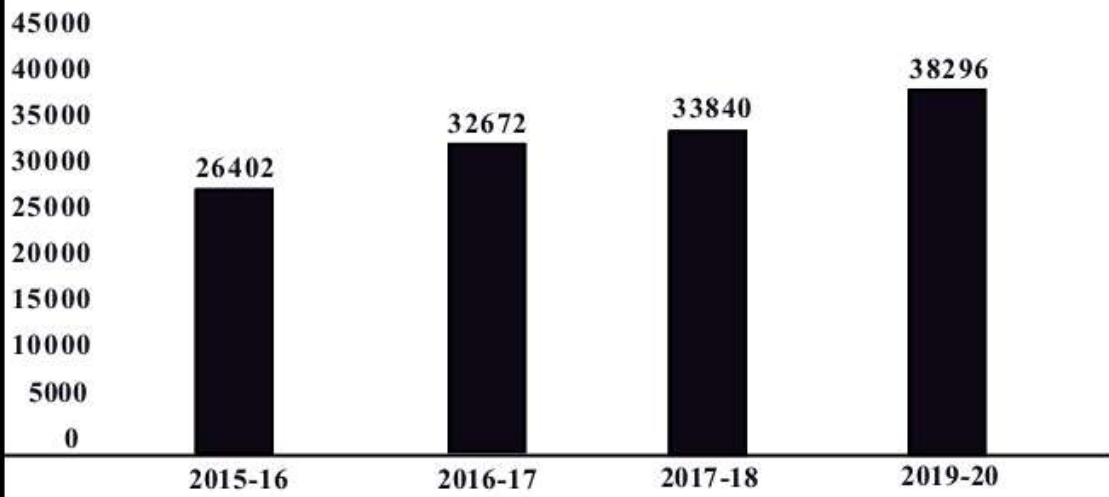
Trustees are available 24 hours for any such emergency needs arising at different hours and sanctions are even given on phone to the doctors. Each trustee manages his personal expenses of travel and communication without any expense to the trust. Hence all the donations are used only towards the benefit of the poor and sick people and minimal administrative charges are incurred by the trust.

Total number of patients seen in 2019-20 in were 20,116 at SSG Hospital and 13,838 at Gotri Hospital and the expenses incurred were Rs 114.22Lakh

### ACTIVITIES DONE IN 2019-20

#### COVID 19

Hari Om Seva purchased 200 PPE Kits at the expense of 2,25,000 and supplied to SSG as it was urgently needed.

## **HELP EXTENDED TO PATIENTS FROM PRIVATE HOSPITALS**

We had introduced a new avenue of helping sick and needy patients outside of the above govt hospitals . Now, needy patients who have taken costly treatments in private hospitals and have run out of their money have come to us for help to settle their bills. Seeing the genuine claims and ascertaining the veracity with the concerned hospitals, the trust has decided to extend help to them and lifted them from their misery and despair. (Documentation of such patients helped in 2019-20 in details on page ( )).

## **LABORATORY DIAGNOSTIC TESTS :**

With the active participation of Hari Om Trust and the Govt. of Gujarat, the laboratory facilities at SSG were greatly enhanced giving relief to scores of patients. Hence the burden and expenses of medical tests were reduced on the trust. Total expenditure incurred in 2019-20 has been Rs 36.83L at SSG and Gotri hospitals. Demand of diagnosis through MRI/CT SCANS, USG, DOPPLER TEST,etc though has increased in both Gotri and SSG Hospitals as the patients are unable to pay for these expensive tests even at Govt. sponsored testing location within SSG. Expenses on MRI/CT SCANS have been 24.19L in the current fiscal year.

## **KNEE AND HIP REPLACEMENT OPERATIONS**

:

Gujarat govt. had introduced benefits of Rs 40,000 to patients needing hip/knee replacements, if they are MAA Card holders. However, in 2019, Govt. of Gujarat changed the policy and decided to pay the full amount spent on the operations. But this did not apply to patients coming from



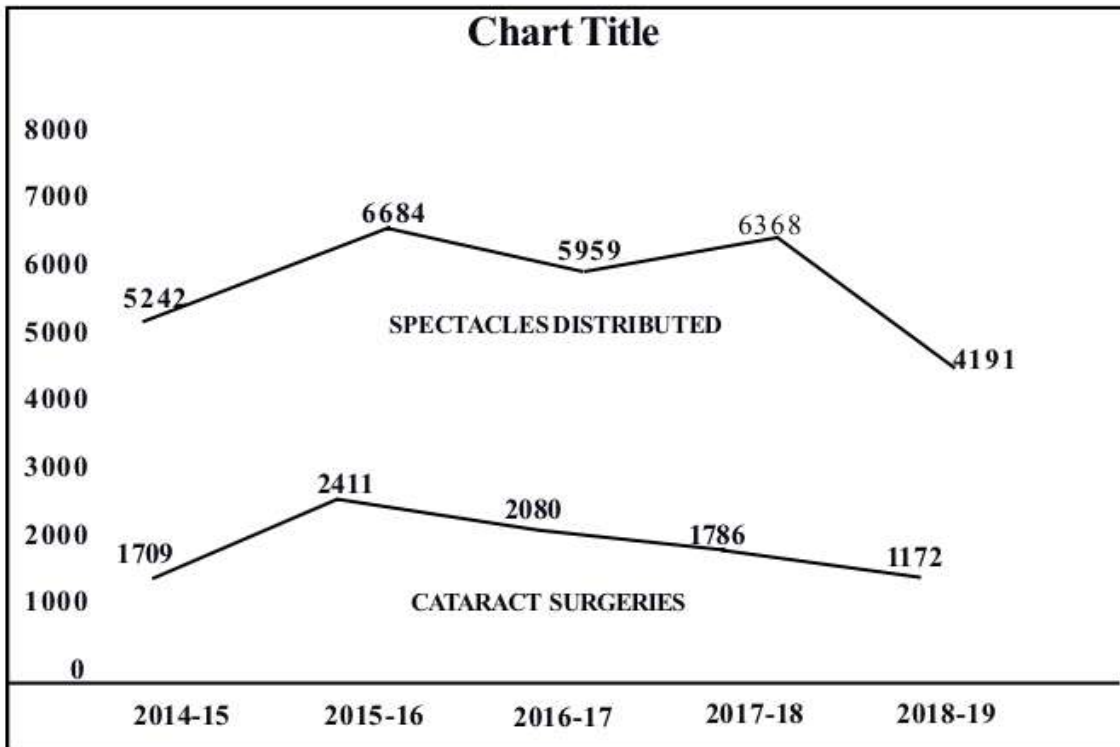
outside Gujarat. Hari Om Seva trust helped such patients as well as those who did not have the MAA card from Gujarat, and the expenses incurred were Rs. 14.55L in the current fiscal year. Total 52 patients were sponsored by the trust out of which 24 patients had hip operations and 7 patients had knee replacements done We are grateful to the Orthopedic team of doctors of SSG who are assisting in every way to bring needy patients to our doorstep. The success ratio in these operations too have been instrumental in spreading the news word by mouth and bringing patients from remote areas in and around Vadodara and other States

### **OTHER MEDICAL AIDS :**

The Diabetic clinic at Kewadia Colony run by Dr. Ashok Gohil is still sponsored by us and a contribution of Rs. 27,000 was sent towards expenses incurred by him in form of medicines and diagnosis.

### **EYE CAMPS :**

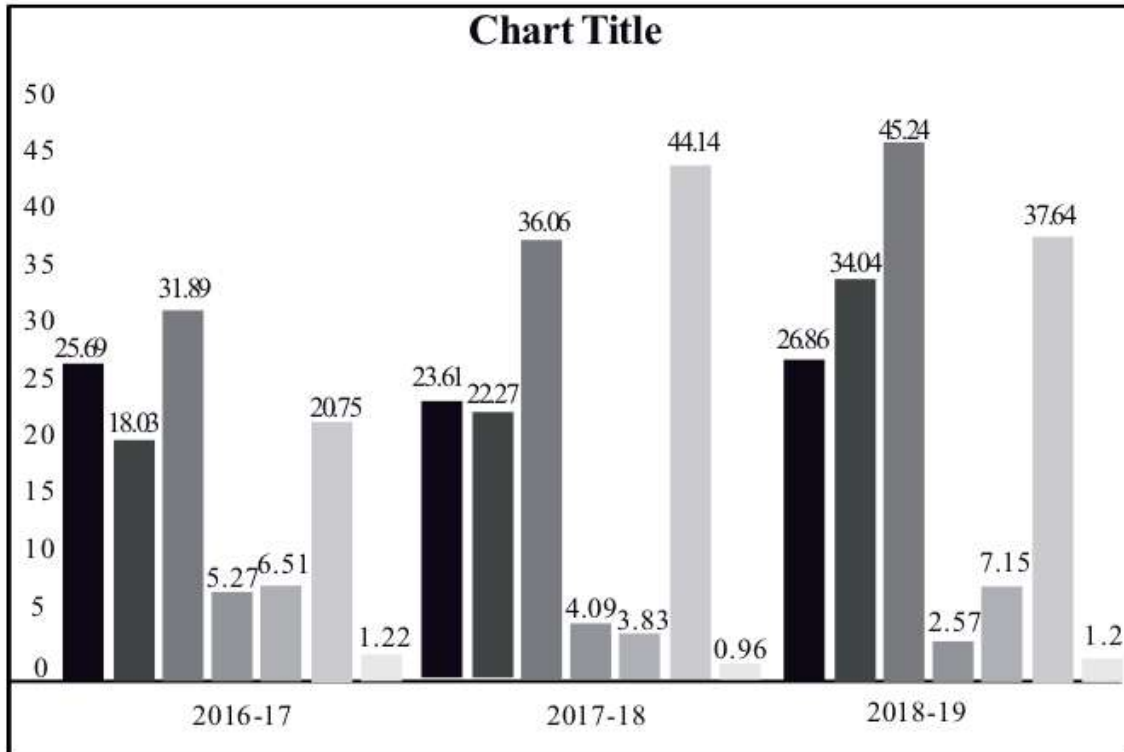
There were 5381 patients in our Eye camps this year. 1039 cataract surgeries were done and 1747 patients were distributed spectacles. Other patients were treated for their various eye ailments. These camps are done in collaboration with DIVYA JYOT TRUST,MANDVI who are managing the actual workings in the camp.



### EDUCATIONAL HELP :

In 2019-20, the trust has helped 142 students at an expense of Rs.9.02L. Considering the high expenses on tuition classes, higher amounts were disbursed to eligible students of Std10<sup>th</sup> and 12th. This activity is done with Mahavir International Trust who does all the background checks and interviews are conducted at their office in Sayajigunj. The quality of impoverished students coming for scholarships is very bright and such students need adequate financial support and encouragements to work on their ambitions. The trust is happy to give this support and help.

**SUPPORT OF DAILY USE EQUIPMENT :**

Need for Airbeds, Nebulizers and Suction machines has grown over the years and those were supplied by the trust on a token deposit. This was returned when the equipment was given back. However, it was found that many patients needed them to be taken home for long use so that too was sanctioned. 43 Airbeds, 19 Nebulizers and 12 Suction pumps were given to needy patients in this fiscal year. Deposits too were waived for the very poor patients.

## **SUPPORT OF EQUIPMENT TO SSG :**

The Orthopedic dept was given a fully equipped Operating Table with all attached accessories as it was urgently required.

## **ASHADEEP**

Mahavir Foundation is providing for education to the slum quarters and those studying in Govt primary schools in different areas within Vadodara.

Hari Om Seva took the onus of providing for one such centre operating in Karelibaug area. Each centre has one teacher and one social worker to look after 25 students. The children are provided with education as well as snacks and are taught for 2 hours daily. The cost of running one centre was Rs 2.5L /year.

## **MUSICAL EVENING FOR THE DIVYANGS(HANDICAPPED)**

The trust had organized musical evening for the physically /mentally challenged Divyangs from different NGOs in February. Singers and orchestra were Smt Rekha Raval and her troupe who have been giving their free services year after year. We are very grateful for their contribution to our motto and their continuous support to this activity. Approximately 350 persons enjoyed the program.

They were served with breakfast, lunch and sweet prasada to carry back home. Our President Rajesh Ahuja as usual financed the program.

## OUR THANKS AND APPRECIATION

## Details of Patient of private Hospitals and received our help

### 1. **Vipranath Dayashankar Pandey**

This patient had gone through kidney transplant at Kidney Hospital (KDRC) at Ahmedabad. He was selling fruits in a lari (cart) for his living. For his kidney transplant he had a saving of Rs. 95,000 only. He had managed to borrow Rs. 2 lakhs from different sources. Further he had received Rs. 1.5 L from the Prime Ministers Fund. He approached the trust for help and brought all the bills of his treatment. After due veracity, the trust sanctioned a cheque of Rs. 25,000 on 25-7-2018 for his dues and helped him in his treatments.

### 2. **Madanlal Narayani**

Madanlal had fallen from the first floor of his home and was taken to Shukan Hospital for treatment. He belonged to a very poor family. His bill from the hospital came to Rs. 2,92,418. The family ran from pillar to post to organize the due amount until they were directed to our trust through a wellwisher. The trust sanctioned Rs. 25,000 in the name of the hospital and even requested the hospital authorities to give maximum discount on the bill. Our request letter was accepted and they waived Rs. 70,000 as a gesture of goodwill. Subsequently, the patient also got an MRI done through us for which no amount was charged.

### 3. **Harish Chandresh Chunara**

Master Harish, 7 years old, suffered from Gullian Barre



Syndrome. He was admitted to a Children Hospital, Akota, Vadodara for treatment. The whole treatment costed him Rs. 1,75,000. The parents deposited Rs. 35,000 from their savings and took a loan of Rs. 25,000 at 5% monthly interest. The family approached the trust and seeing the genuine needs of the destitute family, a cheque of Rs. 25,000 was given to the hospital. Further, the moneylender too was approached to show leniency over the interest charged and a request to lower down the rates.

#### 4. **Ketur Rohitkumar**

Ketur, 37 years old, had serious liver problems since a long time. He was admitted to Gotri Hospital where he was advised to go for a liver transplant. This operation is done at Civil Hospital, Ahmedabad and he got himself operated there. The cost of the operations was Rs. 13 Lakhs. Fortunately, the patient has a MAA card so he received Rs. 4.76 L from the Govt. of Gujarat. Since the patient belonged to a low income group, the hospital gave him 50% concessions on medicine which had to be taken for a very long time. Since the patient was known to the trust, it was agreed to give him monetary help for the rest of 50% towards his long term medications.

#### 5. **Anand Nimavat**

This patient was from Jamnagar and had come to Vadodara to play a football match. In the match, he sustained a Ligament Injury (AGL). He was admitted to SSG where he

needed an operation but SSG did not have a specialized doctor to do this kind of operation. Dr. Mathur requested Dr. Manoj Mehta, Vadodara to do this surgery on him. Charges towards the surgery were reduced from Rs. 1.25 L to Rs. 80,000 by the doctor but the patient could only pay Rs. 35,000. On request of Dr. Mathur, the trust paid rest of the amount of Rs. 45,000 and helped the patient on to recovery.

#### 6. **Ashish A. Chauhan**

Ashish had a spinal injury about 5-6 years back where his spinal cord was damaged. He was admitted to Narhari Hospital for treatment. During that time, his hut near Mataji's Mandir, Pavagadh was demolished by the Govt. authorities. Narhari trust was sympathetic to his problems and allowed him to stay in a small room over their canteen to recover and take physiotherapy and other treatment. There was a gradual improvement in his paralysis. Hari Om Seva trust was approached for further help. Mr. Babani and 2 SSG doctors visited him there to see his situation and sanctioned money towards his medications for more than 15 times. Recently, Narhari hospital demanded charges for the room or asked him to vacate it. Again, Hari Om Seva Trust gave him a cheque of Rs. 20,000 and helped him to stay there to complete his treatment.

7. Another patient who was admitted to Navrang hospital was helped with a cheque of Rs. 10,000 towards his treatment there.
