

# Annual Report - 2020-2021

The year 2020-21 will go down in history as the most difficult year all over the world as the Corona virus created havoc with sickness and death. India saw the worst "second wave" and recorded massive hospitalizations and deaths. Corona wards in **S.S.G and GMERS hospitals** overflowed with patients while there was a fall in O.P.D's of regular patients. As suggested by the doctors, the trust activities were stopped from 20<sup>th</sup> March 2020. However, Hari Om Seva trust rose to the occasion and formed an online- services platform for both the hospitals from 20<sup>th</sup> August 2020 at GMERS hospital and from 17<sup>th</sup> Sept 2020 at S.S.G hospital. It was operated from residence of our Managing Secretory **Mr J.G. Babani**. He was in constant touch with the doctors and assured them that Hari Om trust will support their need- based requirements and ensure that the patients do not suffer.

Paramount Diagnostic Centre arranged for two computers and one printer for us. They also provided two operators, one for each hospital to accept patient's prescription and to mail it to the setup at Mr J.G. Babani's residence. Amin Laboratory also gave one laptop and Mr Nitin Kale provided two persons, one each at both hospitals, to collect blood samples and have a dialogue with the patients to know their requirements. On receipt of the details of patient requirements, the approval was sanctioned and mailed back to the source. The sanctioned documents were printed out and filed for disbursement later to the chemists and the diagnostic centres. 2-3 volunteers sat at Mr J.G. Babani's residence to implement and observe the process. It was due to the dedication of all our volunteers and donors that work could be continued and help given to the needy and sick.

We are thankful to our trustee **Mr. Patankar** who played a lead role in getting the online platform functioning.

In the current fiscal year of 2020-21, there was a fall in the regular patients due to the Covid panic and only emergencies and acute cases came over to the hospitals. The total number of such patients at both hospitals that were helped was 6562. During the year, due to Government guidelines Cataract camps could not be conducted and considering flow of poor and needy patients only the most urgent surgeries were conducted everywhere.

## **ACTIVITIES DONE IN 2020-21**

#### AT S.S.G. HOSPITAL

#### PPEKITS

Hari Om Trust procured 200 PPE Kits at the expense of Rs. 1,76,960 on an urgent basis for the staff as there was a gap between Govt supplies and need requirement.

#### VIDEO OTOSCOPE

There was a request from the Medical Superintendent to provide One Video-Otoscope for the ENT Dept. This was needed to help in explaining the disease conditions and decide on the prognosis. The total cost of the equipment was Rs 96,760.

# STAAN GLORY MULTIFUNCTIONAL FRACTURE TABLE

The Orthopaedic Department needed an Operation Table for patients with max 200 kgs. of weight. The equipment came with multiple other accessories and functions (around 10) that would help manage the patients easily and be convenient to the surgeons as well. The total cost was Rs. 9,91,300 (Rupees Nine Lakhs Ninety-one thousand and three hundred).

The above two items were purchased to meet the needy requirements of the Govt hospital as procuring through proper channels of the Govt would have been time consuming and difficult.

#### DIGITAL MICROSCOPES

Two Digital Microscopes, one each for S.S.G and GMERS Medical colleges, were purchased to be used for better anatomy studies, at the cost of Rs. 5,29,940 (Rupees Five Lakh Twenty-nine thousand nine hundred and forty).

#### ORTHOPEDIC OPERATIONS AT S.S.G

Hip and Knee Operations at Govt hospitals were supported by the Gujarat Govt for those having the MAA Card. However due to Covid expenses all such support was suspended from them during this period. Hari Om Trust stepped in and helped 39 patients for Hip replacements, 13 patients for Knee replacements and 11 for Trauma surgeries. Help given was worth Rs 33,99,000 (Rupees Thirty-Three Lakh Ninety-nine thousands).

#### EQUIPMENT HELP AT S.S.G TO PATIENTS

By taking token deposits, patients were given 24 Airbeds, 2 Nebulizers and 2 Suction machines for their use. Whenever the equipment, were returned they were refunded back with the deposits taken. The token deposits too were waived for the extremely needy and impoverished.

#### ❖ OTHER ACTIVITIES

### Mental Hospital, Karelibaug, Vadodara

There was an urgent need for medicines by the hospital as their supply chain was disturbed due to the Covid. Hari Om trust provided timely intervention with medicines worth Rs 41,750 so that the patients would not suffer due to lack of medications.


#### Diabetic medicine at Kewadia clinic

**Dr. Gohil** was provided with medicines at his diabetic clinic at Kewadia colony worth Rs 44,988in the current fiscal year. He is doing noble work there and his activities are being supported by the trust since many years.

- Hari Om Trust helped 7 patients who were treated in private hospitals for their various ailments. They were given monetary help due to their poor financial conditions to pay the outstanding bills.




